



A striking edifice situated amongst the hustle and bustle of Midtown's elite, 640 Fifth Avenue has the luxury of being situated on a prestigious corner of Fifth Avenue. This remarkable retail space boasts 83 feet of lavish frontage on New York's coveted Fifth Avenue and 117 feet of frontage on 51st Street.

The retail opportunity is comprised of approximately 10,000 square feet on each of the ground and mezzanine levels and the second floor offers an additional 13,000 square feet. Larger space opportunities are available upon request.

The space lends itself to flexibility on both storefront design and space configurations. Ground floor units of 1,500, 2,000, 2,500, 5,000 or 10,000 square feet can be made available. Some examples of the various space opportunities include stunning double-height townhouse concepts with ceiling heights as high as 36 feet and single or double storefront widths.

In addition, larger units such as an urban mansion concept, department store concept, or modern luxury concept are also available. The design possibilities are unmatched and renderings of the various schemes along with corresponding floor plans can be found on the following pages.







FLOOR PLANS - GROUND LEVEL OPTION 2




FLOOR PLANS - GROUND LEVEL OPTION 3




